Investment Policy aims at revamp, expansion, revival of existing urea units and setting up of Greenfield/Brownfiled projects. The fertilizer industry has responded positively to the investment policy only for revamp projects. In absence of commitment for firm allocation of gas at particular price level, the investment for expansion, revival and green field are not forthcoming. A committee has been constituted under the Chairmanship of Dr. Saumitra Chaudhuri, Member, Planning Commission for formulating amendment to the investment policy of 2008.

The Cabinet had in October 2008 constituted an Empowered Committee of Secretaries (ECOS) under the Chairmanship of Secretary (Fertilizers) to evaluate all options for revival of closed units of HFCL & FCIL and make suitable recommendations. Based on the recommendations of the ECOS, a Draft Rehabilitation Scheme (DRS) of HFCL & FCIL have been approved by CCEA for submission to BIFR, on 4th August 2011.
