- (c) by when report of the above Committee on expanded plan of National Capital Region would be ready for implementation idicating to what extent Haryana, Rajasthan, Uttar Pradesh etc. have agreed to the inclusion of ther new districts in NCR?

THE MINISTER OF URBAN DEVELOPMENT AND POVERTY ALLEVIATION (SHRI JAGMOHAN): (a) and (b) A decision had been taken in the meeting of the National Capita! Region Planning Board held on 12-7-2000 to set up a high level group under the Chairmanship of the Urban Development Minister to study the entire gamut of problems concerning the National Capital Region and preapare a new plan for the entire region for the period 2001—2021 and also formulate the new institutional arrangements that may be required. The Board also empowered the Chairman to take a nominee from each of the participating States and to engage experts/study teams, etc. wherever necessary.

(c) The plan is expected to be completed within four months.

- (a) whether Government's target of constructing 20 lakh additional houses yearly i.e. 13 lakh houses in rural areas and 7 lakhs in urban areas was achieved in 1999-2000;
 - (b) if so, the details thereof, State-wise and UT-wise;
- (c) whether Central Government are willing to provide any further financial concession/incentives to States who double their construction activities; and
- (d) what fiscal concessions are available or likely to be given by way of property tax payment/reduction in instalments of loans/tax exemption benefits to Central Government Employees or housing sectors who come forward for housing construction activities?

THE MINISTER OF URBAN DEVELOPMENT AND POVERTY ALLEVIATION (SHRI JAGMOHAN): (a) and (b) Under the 2 million housing programme against the annual target of 7 lakh urban houses, Government has facilitated construction of 7.34 lakh houses through different agencies. In the rural areas, through programmes of HUDCO and Ministry of Rural Development 12.54 lakh houses have been sanctioned/constructed, State-wise details are given in the Statement (See below).

- (c) No such proposal is presently under consideration.
- (d) Government has provided various fiscal concessions under the I.T. Act as well as Custom and Excise Duty exemptions to the housing sector over the years at the time of finalisation of budget. The State Governments have also been advised to consider reduction of stamp duty and registration charges as also other measures which would encourage housing activity.
