- (c) by when these payments would be made?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI BHARATSINH SOLANKI): (a) No, Sir.

(b) and (c) Do not arise.

#### Slow speed of trains in Uttar Pradesh

2785. SHRI MOHAMMED ADEEB: Will the Minister of RAILWAYS be pleased to state:

- (a) the areas/sections in Uttar Pradesh where the average per hour speed of trains is less than 50 kilometres;
  - (b) the reasons therefor; and
  - (c) the steps taken to improve the situation?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI BHARATSINH SOLANKI): (a) to (c) Indian Railways do not run new train services on State-wise basis as Railway network and train operations run across state boundaries.

Speeding up of trains is a continuous process on Indian Railways and is dependent on optimization of the investments made by Railways in modernization of technology, high powered locos, modern coaches and better tracks.

THE MINISTER OF STATE OF THE MINISTRY OF STATISTICS AND PROGRAMME IMPLEMENTATION (SHRI SRIKANT JENA): (a) As per information received from the district authorities, there are three MPs of 15th Lok Sabha and 22 sitting MPs of Rajya Sabha for whom no sanctions have been issued for developmental works under the MPLAD Scheme for utilization of funds. The names, party and constituency of these MPs are given in the Statement (*See* below).

- (b) The general complaints received in the Ministry from time to time, include: delay in implementation of MPLADS works by district authorities, mis-utilization of funds, execution of in-eligible works, forged recommendation letters, incomplete works and poor use of assets, etc.
  - (c) No, Sir.
  - (d) Does not arise.
