Utilisation of cess collected under Building Construction Workers Act

270. SHRI M.P. ACHUTHAN: SHRI R.C. SINGH:

Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:

- (a) whether it is a fact that only a small percentage of the cess collected by various States under the Building and Other Construction Workers Welfare Cess Act, 1996 is actually spent for the purpose it is collected;
- (b) if so, the State-wise details of the workers registered, cess collected and the amount spent on the welfare of the registered works since its inception in 1996; and
- (c) what measures are being taken to ensure that the funds collected are spent for the welfare of its workers?

THE MINISTER OF LABOUR AND EMPLOYMENT (SHRI MALLIKARJUN KHARGE): (a) and (b) As per the information received from the State Governments, the number of workers registered, amount of cess collected and amount spent under the Building and Other Construction Workers Welfare Cess Act, 1996 is as under:—

(c) The responsibility of collecting cess and its utilization for welfare activities lies with the respective State Governments and State Building and Other Construction Workers Welfare Boards. The Central Government has been impressing upon the State Governments to implement the provisions of the Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Act, 1996 and Building and Other Construction Workers Welfare Cess Act, 1996 effectively. The Central Government has issued directions to all States/UTs under Section 60 of the Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Act, 1996 for proper implementation of the Act.

Contractual labour

†271. SHRI RAMCHANDRA PRASAD SINGH: SHRI RAVI SHANKAR PRASAD:

Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:

- (a) whether it is a fact that the practice of engaging contractual labour for execution of work has increased during past one decade in the country;
 - (b) if so, Government's reaction thereto;
- (c) whether it is also a fact that 90 per cent labourers are still in the unorganised sector in the country;
- (d) if so, whether it is also a fact that the number of labour strikes in factories of the country during the years 2008-09, 2009-10, 2010-11 are less than the incidents of lock out by owners; and
 - (e) if so, the details thereof?

THE MINISTER OF LABOUR AND EMPLOYMENT (SHRI MALLIKARJUN KHARGE): (a) No specific study has been conducted to assess whether the number of contract labour in the past one decade in the country has increased. However, it is observed that in the Central Sphere there has been a marginal increase in the number of contract labour in the country.

- (b) In the Central Sphere establishments in order to safeguard the interest of contract workers, inspections are conducted under applicable labour laws regularly. Appropriate action is taken against defaulters, including initiating prosecution proceedings.
- (c) As per the survey carried out by the National Sample Survey in 2004-05, the number of workers employed in unorganized sector is more than 90%.
 - (d) and (e) The details of Strikes and Lockouts for the years 2008 to 2011 are
