Instances of rape increasing fastest among crimes

232. SHRI BALWINDER SINGH BHUNDER: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether according to crime data of National Crime Records Bureau (NCRB), the instances of rape have increased fastest among the major crimes;
- (b) if so, the details in this regard and the reaction of Government thereto; and
- (c) what efforts have been made to make the women safe?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI JITENDRA SINGH): (a) to (c) As per the information provided by the National Crime Records Bureau (NCRB) crimes against women under different headings from 2008-10 is given in Statement (See below). As evident from the data, the instances of rape are not the fastest increasing crime against women.

As per Seventh Schedule, 'Police' and 'Public Order' are State subjects under the Constitution, and as such the primary responsibility of prevention, detection, registration, investigation and prosecution of crimes, including crimes against women, lies with the State Governments and Union Territory Administrations. However, the Union Government attaches highest importance to the matter of prevention and control of crime against women. Ministry of Home Affairs has sent detailed advisories dated 4th September, 2009 to all State Governments/UTs, wherein they have been, *inter-alia*, advised to adopt appropriate measures for swift and salutary punishment to the persons found guilty of violence against women,
