## Detection of insecticidal protein in human blood

103. SHRI R.C. SINGH: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) whether Government is aware that as per the study conducted by the University of Sherbrooke, Canada, scientists have detected insecticidal protein, Cry 1 Ab, in the human blood;
- (b) whether it is a fact that as per the study, Bt. Toxin does not break down in the human gut; and
- (c) what would be the Ministry's approach to the existing Bt. Crops and on those Bt. Crops which are going to be introduced in the country in view of the findings thereof?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI SUDIP BANDYOPADHYAY): (a) and (b) The Study reports that scientists in Canada have detected the presence of Cry I Ab which is one of the residues derived from GM crops in the blood of both pregnant and non-pregnant women as well as in fetal cord blood. The study also suggests that the toxins derived from insect resistant GM crops may not be effectively eliminated in humans.

(c) Information is being collected and will be laid on the Table of the House.

THE MINISTER OF HEAVY INDUSTRIES AND PUBLIC ENTERPRISES (SHRI PRAFUL PATEL): (a) There are two Departments namely Department of Heavy Industry (DHI) and Department of Public Enterprises (DPE) under the Ministry of Heavy Industries and Public Enterprises. The details of sanctioned staff strength in the Ministry, Group-wise *i.e.* Group A to Group D is placed as under:—

The respective Cadre Control Departments are responsible for following the Government of India's reservation policy while making appointment to the post.

## Frequent hike in petrol prices

- (c) what preventive steps Government has taken to devise such a mechanism that frequent petrol price hike may not take place and the common man is saved from the impact of rise in oil prices and other essential commodities as a result thereto?
