THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI SUDIP BANDYOPADHYAY): (a) to (c) Presently, Government does not have a specific programme separately for addressing the health problems of urban poor living in slums. However, Urban Reproductive and Child Health (RCH) component under National Rural Health Mission (NRHM) caters to the health care needs of the urban dwellers including urban poor people living in slums. Protection of people suffering from NTDs in the country

72. SHRIMATI SHOBHANA BHARTIA: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) whether international researchers have warned that India has more than 290 million people suffering from Neglected Tropical Diseases (NTDs);

(b) if so, the reaction of Government thereto;

(c) whether Government proposes to take effective steps to protect the citizens from the NTDs; and

(d) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI SUDIP BANDYOPADHYAY): (a) to (d) Yes. Important Neglected Tropical Diseases (NTDs) in India are Dengue, Trachoma, Leprosy, Guinea Worm, Lymphatic Filariasis, Soil-transmitted Helminthiases. Under the following national programmes, strategies are being implemented to control or eliminate these diseases:—

(i) National Vector Borne Disease Control Programme implements the strategies for the control of Dengue and elimination of Lymphatic Filariasis.
