Association (IMA) have not endorsed this three-and-half years degree course in view of the patient's safety; and

(c) if so, the reaction of Government thereon and how it is going to be resolved?

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI GHULAM NABI AZAD): (a) Yes. The Central Government is considering to start a course to be called Bachelor of Rural Health Care (BRHC) with the purpose of generating a cadre of health care providers who by the virtue of the way they are chosen, trained, deployed and supported would be motivated to live in and provide comprehensive health care in rural areas at Sub Centre level.

(b) and (c) Though the proposal for BRHC has been prepared in consultation with MCI, a few associations like IMA have not welcomed the proposal. Nonetheless, in order to address the serious concern availability of human resources in health sector in rural areas, the Government is committed to introduce the course, with inbuilt safeguards.

Financial assistance for launching emergency services

- 80. SHRI DILIPBHAI PANDYA: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:
- (a) whether Government has provided financial assistance for launch of 108 emergency services in the country;
 - (b) if so, the details thereof, State-wise;
- (c) whether Government under the National Rural Health Mission (NHRM) has given contracts for ambulance and emergency healthcare services to private parties in ten States including Gujarat; and
- (d) if so, the details thereof alongwith the names of private players which were awarded the contracts and the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI SUDIP BANDYOPADHYAY): (a) Yes, Under the Mission, funds are provided to State/UTs to strengthen their health care delivery system in rural areas. Funds are released to all State /UT Governments for the approved activities including 108 Emergency services.

- (b) State-wise details are given in the Statement (See below).
- (c) and (d) State/UT Governments as per their felt needs and priorities, incorporate their proposals for ambulance and emergency healthcare services in their annual Programme Implementation Plan [PIPs] under NRHM. Based on approval accorded by Government of India, they are taken up for implementation by respective State/UT Governments. The model for implementation of the programme/particular activity is selected by respective State/UT Government depending upon their requirement and suitability.
