and are managing some textile mills. However, no scheme has been received from State Governments for starting State Textile Corporations with a view to taking over sick textile mills in their States.

However, due to increase in the cost of operation consequent on the hike in prices of aviation fuel and also their tight fleet position Indian Airlines had to review their plans and found themselves unable to operate to Calicut in the Fifth Plan period. The project has therefore, been deferred for the present.

THE MINISTER OF COMMERCE AND CIVIL SUPPLIES AND CO-OPERATION (SHRI MOHAN DHARIA): (a) The main problem of the cashew industry is the shortage of raw nuts for processing. The Central Government have, therefore, taken steps to import as large a quantity of raw cashew-nuts as available. The Central Government have also taken in hand various schemes for increasing indigenous production of raw cashewnuts.
