The data for 1973-74 and 1974-75 are still being compiled by the implementing agencies; part of the data has been received and is being processed.

(c) While fixing the minimum support prices for kapas for the 1975-76 season, the Government considered, among other things, the recommendations of te Agricultural Prices Commission in this regard. The Commission, it may be mentioned, took into account the available data on cost of cultivation/production of kapas, including those referred to above, and other relevant issues while making their recommendation on the subject.

SINGH): (a) and (b) The Government of India have agreed to provide a special advance plan assistance of Rs. 3.5 crores during the current year to the Governmnt of Andhra Pradesh for Nagarjunasagar Project with a view to accelerate works on the project, subject to certain conditions.

Within the framework of broad policy, the State Governments are free to decide their own strategies for implementation of the program-Comment Days

- (b) The Harvana Government took the decisions on their own on the incentive scheme and no specific approval of Central Government was sought for.
- (c) The Central Government has not vet adopted similar measures for its emplovees. The decisions taken by the Haryana Government have been brought to the notice of the other State Governments.
