(b) whether Government have decided to revise the agreements with the foreign, shipping lines and if so; the details thereof?

THE MINISTER OF SHIPPING AND TRANSPORT (DR. G. S. DHILLON) : (a) There is evidence to indicate that some foreign non conference shipping lines are operating their vessels in India's overseas trade in which Tndian Lines have been operating as members of Conferences and joint shipping services.

(b) No, Sir. However, Government is considering measures for protecting the interests of Indian shipping in India's overseas trade.

FAREWELL TO SHRI B. N. BANERJEE THE RETIRING SECRETARY-GENERAL AND WELCOME TO SHRI BHALERAO THE NEW SECRETARY-GENERAL OF THE BAJYA SABHA

MR. CH \TRMAN : I have to inform the House that Shri B. N. Banerjee has retired from the office of the Secretary-General of the Rajya Sabha with effect from the afternoon of April 1, 1976,

Born in 1916 and educated at Calcutta, and London School of Economics, Shri Banerjee joined the Bengal Judicial Service in 1942. After a meritorious record of service there, Shri Banerjee joined the Ministry of Law, Government of India, and also served as Legal Adviser to the High Commissioner for India in London. In 1956 he joined the Rajya Sabha Secretariat as Deputy Secretary and in 1963 he was promoted as Joint Secretary in that Secretariat. He was appointed as Secretary of the Rajya Sabha in October, 1963. Consequent on the redesignation of the post of Secretary, Rajya Sabha, as Secretary-General, Rajjya Sabha, Ihe was appointed to that post in November, 1973.

Shri Banerjee worked as Secretary to this House for more than 12 years and his picture was marked by considerable changes, both constitutional and procedural. He set a unique record of service to our House

and helped in maintaining the highest traditions of Parliamentary system. The Rules .of Procedure went through several substantial changes during his term of office and he had made important contributions to the same. His relationship with all members of the House was very cordial and he was always available to them for giving whatever assistance or advice asked irrespective of their party affiliations

He accompanied several Parliamentary Delegations abroad and attended many Presiding Officers' Conferences and Conferences of the Secretaries of various State Legislatures.

He also actively participated in the Twenty-Commonwealth Parliamentary Conference held in New Delhi in November last year wherein India played the host.

With his vast experience and sound J knowledge, he was of great help to me since I I became the Chairman and ha gave good advice on complicated procedural matters.

His relationship with officers and his subordinates was also very cordial and he was sympathetic to all members of tho staff whenever they had any difficulty. By his dealings he endeared himself to all those who came in contact with him—Ministers, Members and Officers alike and he erajoy-\ ed the love and confidence of them all.

On behalf of the House. I pray for his sound health and long life.

1 have also to inform the House that I have appointed Shri S. S. Bhalerao, our Additional Secretary as Secretary-General of the Rajya Sabha.

Educated at Ferguson College, Gokhale Institute of Politics and Economics and Law College, Poona, Shri Bhalerao started his career as Assistant Secretary in the Hyderabad Legislative Assembly. Later he joined the Law Department, Government of Bombay and cams over to the Rajya Sabha Secretariat as JDeputy Secretary in November, 1958. He was promoted as Joint Secretary in that Secretariat in December, 1963 and Additional Secretary in December, 1974.

SHRI OM MEHTA: Sir, as just now to!d by you, we see a change in the House today. A seat which was being occupied by Shri Banerjee for the last 12 years is now occupied by Shri Bhalerao, who used to sit on the right side of Shri Banerjee.

AN HON. MEMBER: He was sitting on the Chairman's left.

SHRI OM MEHTA: Yes, on his left.

Sir, I extend to him our sincere congratulations and good wishes for a successful term in this high office. Shri Banerjee, I am sure the whole House will be happy to know it, will take his seat with us tomorrow. The President has been pleased to nominate him as a Member of this august House. Shri Banerjee is a person of rare qualities. With all his high academic distinction—he is a Barrister and LL.M. from; Loudon and a Gold Medalist—he is a man of extreme modesty. He joined the Rajya Sabha Secretariat in the year 1956 as a Deputy Secretary and earned his promotion to the highest office by merit and unstinted work.

During the last twenty years he haa grown into an institution in this Parliament House and Members, irrespective of their party affiliations, always went to him for help and guidance in their parliamentary work. His advice was always correct and earned for him the respect and admiration of all Members including Ministers.

He has served, a galaxy of Chairman of the Rajya Sabha including you, Sir, as told by you just now and, I hope, I will not he considered presumptuous if I sav that he was held in esteem and trust by all of them.

Sir, his nomination to the Rajya Sabha is a fitting tribute to his excellent record of good work and his high personal qualities as the foremost servant of the Rajya Sabha.

To me gersonally, Sir, Shri Banerjee has been a close friend and I have found collaborating with him always most fruitful and .purposeful. I am happy that his association with the Rajya Sabha continues. He has now a wider field to serve not only the Parliament but the country as a whole.

Sir, on behalf of all Members of the Rajya Sabha I offer him our very warm and affectionate felicitations and good wishes.

SHRI BHUPESH GUPTA (West Bengal): Sir, I join you in expressing our deep satisfaction and admiration for the services rendered to this House by Mr. Banerjee over the past two decades. As has just now been pointed out, an inarticulate and yet not a Member of the House and yet a Member, he would now be an articulate Member of the House and naturally his services will now be available not in the form of advice that he may speak from that chair which is just below you but in the speeches and other contributions that he would be making. We will naturally be happy to have him with us.

Sir. I have watched Mr. Banerjee maintain the high traditions of the House from this office functioning as the Secretary-I General not of any individual party or group of individuals but of the House as a whole. The reflection of the collective sense of responsibility that attaches to that office is of high significance not only for the office itself but for the work of the House.

Mr. Banerjee, Sir, if I may say so, belonged to the same College to which I belonged, namely, the Scottish Church College. Though I was not there for long—because I was arrested after a year—hi continued and studied ihere. I did not know him personally there but when he came to the House I at once found a man of distinction who understood the problems of the House and who tried to help the Members; that was very very important.

Sir, he was a communication channel between the Members of the. House on the one hand and the Chair, on the other. As you know, Sir, sometimes it is very difficult to reach the Chair and much more so to convince it. Mr. Banerjee acted as a good mediator to synchronise the role of the Chair and that of Members of the 1 House in such a manner that the House

[Shri Bhupesh Gupta] functions in excellent symphony of democracy; and that happened. Sir, his informed silence in the House helped the House to be more and better articulated and that again is a tribute to him.

Sir, I need not say very much about him because he will be here and we will be talking to him and he will also be speaking. Therefore, I do hope Mr. Bhalerao will be carrying forward the high qualities of Mr. Banerjee and the traditions that he left in this House.

Finally, i would like to say that the Secretary-General shall always function as the Secretary-General of the House as a whole. That is very very important. He has in him the trust of the whole house placed. The quality and excellence of his

work will be tested by the manner in which he responds to the temper, the mood, the aspirations and the urges of the entire House. Thank you, Sir.

I have been associated with Mr. Banerjee not only as a Member, the Deputy Chairman of the also as House. I must say that but for Mr. Banerjee, my task would have been very much difficult. On many occasions I have found that the Presiding Officers have to rely entirely on the Secret tary-General for his advice and for his knowledge of the rules and procedures, the precedents sei up in tht House, the conventions followed in the House and so many other things. Mr. Banerjee has not only distinguished himself as a good administrator—I know how he administered the staff and the Secretariat of the Rajya Sabha— but he, has also distinguished himself as one who moved with the Members and. Unless you know what is really important for the Members, it is very difficult to satisfy the Members and in this respect, I think, Mr. Banerjee has been very useful to the House because he had tried to go and talk to the Members, befriend the Members and at times saw to it that they had no grievance at all while functioning i_D, House. I think this is very essential for any Secretary-General, and with all the experience he has had in this House and with the friendship that he was able to build up with most of the Members who came into this House, he had endeared himself to all

of us. Therefore, we would have, perhaps, felt his absence as Sec:etary-General. But we are glad to hear that he will be nominated to this House and so, he will always be available to us for advice and guidance whenever we need it from him. It is a good thing that an ex_Secretary-General with such vast experience as he has had not only in constitutional and legal matters but also in th; functioning of this. House would !be available *to* u« for advice. Sir, I would personally like Jo thank him for all the cooperation and assistance that he was able to give me in the discharge of my duties.

At the same time, Sir, I would' like to welcome Mr. Bhalerao to his new job. Because he has been with us, I do not think we will miss anything that way, Mr. Bhalerao will be administering the Secretariat as Secretary-General and Mr. Ba.ne.rjee will be a Member of our House, and thus we will have both of them. Mr. Bhalerao has had a lot of experience in our House and he has been administering the Secretariat along with Mr. Banerjee. I think we are very fortunate to have a smooth change-over in the Secretary-General's post.

Therefore, Sir. I would like to take this opportunity of congratulating both of them.
