

(b) The gross storage capacity of the Gandikota Reservoir as proposed by the Andhra Pradesh Government is 6,100 MCFT for irrigating 75,000 acres of land.

(c) Pulivendla Canal project does not form part of the Tungabhadra High Level Canal Stage II Scheme. However, the project envisages utilisation of 4.5 TMC of Tungabhadra waters.

**DRUGS PRODUCED AT THE INDIAN  
DRUGS AND PHARMACEUTICALS LTD.**

\*51. SHRI C. ACHUTHA MENON : Will the Minister of PETROLEUM AND CHEMICALS be pleased to state :

(a) what are the products scheduled to be produced at the Indian Drugs and Pharmaceuticals Ltd. this year and in what quantities;

(b) how far the plant will make the country self-sufficient with regard to our requirements of any of the drugs now being produced there; and

(c) how do the prices of the drugs produced at this factory compare with the prices of the similar drugs which are produced by other drug houses now being sold in the country?

THE MINISTER OF PETROLEUM AND CHEMICALS AND SOCIAL WELFARE (SHRI ASOKA MEHTA) : (a) A statement showing the tentative production targets fixed in November 1967 is laid on the Table of the House. But due to various technical difficulties and teething troubles these targets may not be achieved in full. (See below)

(b) With the plants at Rishikesh and Hyderabad achieving full production, the country is likely to become self-sufficient in penicillin, tetracyclines, INH and Diethyl Carbamazine citrate and nearly self-sufficient in streptomycin and some sulpha drugs.

(c) They are comparable.

(a) whether it is a fact that the Silver Jubilee T. B. Hospital at Kingsway Camp in Delhi has got provision for 1200 I beds with only one T.B. Specialist who is also functioning as the Hospital Superintendent there and as such, most of the patients of the hospital do not receive attention of the Specialist;

(b) whether it is also a fact that at a distance of hardly two furlongs from this Hospital there is the Vallabhbai Patel Chest Institute with large number of Chest Specialists and other Specialists engaged for research in diseases of the chest but for want of enough scope of research works there they devote their energies in manufacturing certain chemicals; and

(c) if the answers to parts (a) and (b) above be in the affirmative, whether there is any proposal for coordination between these two neighbouring institutions for proper utilisation of the talents as well as treatment of the patients in Silver Jubilee T. B. Hospital ?

THE MINISTER OF HEALTH, FAMILY PLANNING AND URBAN DEVELOPMENT (SHRI SATYA NARAYAN SINHA) : (a) No, Sir.

#### AUTOMATIC MACHINES IN THE INCOME TAX DEPARTMENT

\*53. SHRI JAGAT NARAIN : Will the Minister of FINANCE be pleased to state :

(a) whether there is any proposal under Government's consideration to introduce automatic machines in the Income Tax Department;

(b) if so, the work of how many clerks will be performed by a unit of such machines in the cities like Calcutta, Bombay and Madras; and

(c) how much amount is paid to these clerks as salaries, etc., per annum and how much expenditure including

compound interest, depreciation, rental fees and other working charges, will be incurred on these machines to do the same amount of work ?]

वित्त मंत्रालय में राज्य मंत्री (श्री के० सी० पन्त) : (क) जी नहीं। तथापि, यह उल्लेख कर दिया जाय कि कुछ अधिक बड़े केन्द्रों में वेतन के मामलों में कर-गणना की जांच, उन अभिकरणों/कम्पनियों से संगणक कुछ समय के लिए किराये पर लेकर की जाती है, जिनके पास यह सुविधा उपलब्ध है। केन्द्रीय सांख्यिकीय संगठन में उपलब्ध संगणक सुविधा का उपयोग अखिल भारतीय राजस्व सांख्यिकी के संकलन के लिए किया जाता है।

(ख) और (ग) यह प्रश्न नहीं उठता, क्योंकि कलकत्ता, बम्बई अथवा मद्रास में आयकर विभाग में इस प्रकार की कोई मशीनें नहीं लगायी गयी है।

[THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI K. C. PANT) : (a) No, Sir. It may be mentioned, however, that tax calculations in salary cases are being checked in some of the larger centres by hiring computer-time from agencies/companies which have the facilities. The computer facility available with the Central Statistical Organisation is being utilised for the compilation of All India Revenue Statistics.

(b) and (c) Do not arise as no unit of such machines has been set up at Calcutta, Bombay or Madras in the Income-tax Department.]

S. Dollars, Indian currency and smuggled luxury goods;
