- (a) Yes, Sir.
- (b) The recommendation in so far as it related to honorary judicial magistrates has been incorporated in the Union Territories (Separation of Judicial and Executive Functions) Bill, 1968 which was introduced in the Lok Sabha on 26th April, 1968. However, provision for appointing honorary executive magistrates has been retained in the Bill.
