

THE MINISTER OF INFORMATION AND BROADCASTING (SHRI K. K. SHAH) : (a) Capital expenditure incurred by All India Radio on the Tele-vision Centre, Delhi, till the end of March, 1968, was Rs. 30.54 lakhs. The recurring expenditure on the Delhi T. V. Centre during the year 1967-68 was Rs. 27,71,900.

(b) As on 31-12-1967\* 6184 T. V. sets were licensed in the country.

(c) It has been decided to set up a T.V. station at Srinagar. The estimated expenditure is approximately Rs. 100 lakhs. An additional sum of Rs. 67 lakhs is likely to be incurred on setting up of community viewing centres.

It is also proposed to set up T. V. Centres at Bombay, Madras, Calcutta and Kanpur, with limited facilities, and to expand the Delhi T. V. Centre, at a cost of Rs. 3.75 crores, during the Fourth Five-Year Plan.

(c) how many persons have been given visas ?

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SURENDRA PAL SINGH) : (a) Our High Commissioner in Kenya visited Delhi in May, 1968 to discuss the question of permanent settlement in India of persons of Indian origin in Kenya holding British pass ports who do not wish to go to U. K. but instead wish to settle in India.

(b) The existing arrangements regard ing temporary visas still continue.

(c) About 3,700 persons of Indian origin holding British passports.

(a) whether it is a fact that the British military bases are going to be removed from the Indian Ocean area by 1961;

(b) if so, whether the Government of India alongwith other friendly countries propose to immediately fill the vacuum thus created; if so, by when and in what manner; and

(c) what immediate action is being contemplated by the Government of India so that no other nation, whether friendly or hostile to India can establish its own base in the Indian Ocean and the security of our country or any other country in the area is not endangered ? ]

वैदेशिक-कार्य मंत्रालय के राज्य मंत्री (श्री बी० अर० भगत) : (क) 16, जनवरी, 1968 को ब्रिटेन के प्रधान मंत्री ने हाउस आफ कामन्स में घोषणा की थी कि ब्रिटेन ने 1971 तक स्वेज़ के पूर्व में वर्तमान सैनिक दबाव को हटाने का निर्णय कर लिया है। इससे पहले उन्होंने यह भी घोषणा की थी कि अल्डब्राना द्वीप का विकास करने की योजनाओं को छोड़ दिया गया है।

(ख) और (ग) हम तो इस बात में विश्वास करते हैं कि इस क्षेत्र के देशों की सुरक्षा अंततः उनकी अपनी राष्ट्रीय शक्ति पर और प्रभुसत्ता प्राप्त तथा स्वतंत्र राज्यों के रूप में एक-दूसरे के स्वच्छ या सहयोग पर ही निर्भर होनी चाहिए।

[THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI B. R. BHAGAT) : (a) On 16th January, 1968 the British Prime Minister announced in the House of Commons that Britain had decided to withdraw its existing military presence east of Suez by 1971. He had also announced earlier that plans to develop Aldabra island had been given up.

(b) and (c) We believe that the security of the countries in the region must rest ultimately on their own national strength, and on their willing cooperation between one another as Sovereign independent States.]

#### HANGING OF AFRICANS IN RHODESIA

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SURENDRA PAL SINGH) : (a) to (c) Although Government are not aware of any such statement by the Zimbabwe African National Union, they have seen press reports about such secret hangings of Africans in Rhodesia. Government would naturally view such happenings with horror and condemn such atrocities. Their representatives have been consistently demanding the early end of the illegal minority regime of Rhodesia and drawing world's attention to its atrocities.
