THE MINISTER OF INDUSTRIAL DEVELOPMENT AND COMPANY AFFAIRS (SHRI FAKHRUDDIN ALI AHMED): (a) The

company is managed by the Board of Directors where two of the members of the Jatia family are directors. A nominee each of the Government of Assam and the Industrial Finance Corporation are also on the Board.

(b) The unsecured loan taken by this company from the private limited companies where two of the directors

(b) and (c) In Ganjam District (Orissa) it was first decided to limit the renewals of Salt Department lands to private parties to 50 acres in order to promote and develop the cooperative section in the manufacture of salt, whenever opportunities arise. Later, on reconsideration it was finally decided to limit the area to 75 acres. It became necessary to raise the limit from 50 acres to 75 acres to lessen the effect

of reduction on lessees concerned having regard to the fact that performance of the lessees was reported to be satisfactory. In this view, it has been decided not to change the decision already taken.
