

superphosphate produced at the superphosphate factory at the Zinc Smelter, orders were secured for a total quantity of 26,665 tonnes of which 23,564 tonnes have been despatched. The present stock is about 19,000 tonnes. Due to lack of demand the Company is facing difficulty in disposing off the stocks and they are continuing their efforts to secure further orders.

(b) The capacity of superphosphate production at Debari had also been taken into account along with the production capacity of other factories in the country for purposes of estimating the demand and supply of fertilizers.

(c) Yes, Sir. The consumption of zinc concentrates at the Zinc Smelter is on an average of 120 tonnes per day while production of concentrates at the captive mines of the Smelter is approximately 40 to 45 tonnes per day. The gap is being met for the present from the stock of concentrates produced during the period before the Zinc Smelter had been commissioned. Arrangements are being made for short term import of concentrates from abroad to maintain production at the rated capacity when the existing stock gets exhausted and till the mines attain the requisite capacity.
