

THE DEPUTY PRIME MINISTER AND MINISTER OF FINANCE (SHRI MORARJI R. DESAI) : (a) Financial implications of the recommendations made by the Joint Committee of Parliament on the Salaries and Allowances and other Amenities to Members of Parliament have not yet been worked out. The detailed calculations would require consultation with various Ministries concerned with the recommendations and the financial implications cannot, therefore, be immediately given.

(b) If cent per cent neutralisation calculated at the lowest of the existing pay ranges, is given at the average of index 205, to which the current rates of dearness allowance are related, to Central Government employees drawing pay below Rs. 500 p. m., the additional annual expenditure would be of the order of Rs. 102 crores.
