Associations or Chambers of Commerce. These can be issued in Hindi only after adequate facilities for carrying official work in Hindi are provided for the Government offices concerned. These facilities include or ovision of adequate number of Hindi trained staff and provision of Hindi Typewriters, etc. Action is being taken to provide these facilities as early as possible.

(b) A specific time limit cannot be given as this is linked with the larger question of progressive use of Hindi in all the Government offices for which expeditious action is being taken, as stated above.]

COMMUNITY HALL AT KIDWAI NAGAR

- 1407. DR. BHAI MAHAVIR: Will the Minister of WORKS, HOUSING AND SUPPLY be pleased to state:
- (a) whether it is a fact that the Community Hall of Kidwai Nagar, New Delhi was allotted to the Bharat Sevak Samaj in contravention of the general instructions to the effect that such halls were to be used by the residents of the area;
- (b) whether it is also a fact that the allotment was cancelled w.e.f. 1st July. 1965 but the possession of the hall has not been surrendered by the Samaj till date;
- (c) whether the market rent chargeable from the Bhavat Sevak Samaj from that date has not been recovered so far:
- (d) if so, what steps Government are taking in the matter?

THE MINISTER OF WORKS, HOUSING AND SUPPLY (SHRI JAGANNATH RAO): (a) No. The Community Hall at Kidwai Nagar was allotted to the Bharat Sevak Samaj in 1958, when the Samaj was treated as a limb of the Planning Commission, for carrying out welfare activities for the residents of the area.

(b) The rent free allotment was cancelled with effect from 1st July, 1965

and the Samaj was told that the market rent would be charged for the accommodation continued to be retained by them beyond 30th June, 1965. The Samaj is still in occupation of the hall.

- (c) Yes, as the Samaj had represented against such recovery.
- (d) Proceedings under the Public Premises (Eviction of Unauthorised Occupants) Act, 1958 have been initiated.
