PLANNING AND URBAN DEVELOP-MENT be pleased to state:

(a) whether the Government of India have undertaken any measures for the evaluation of the performance of family planning programme through a body of experts and impartial agencies;

(b) if so, what are those measures and the results thereof; and

(c) if the answer to part (a) above be in the negative, whether Govern, ment propose to assess the results of the expenditure and efforts made so far with regard to family planning?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH, FAMILY PLANNING AND URBAN DEVELOP-MENT (DR. S. CHANDRASEKHAR) : <a) Yes, Sir.

(b) At the request of the Government a United Nations Advisory Mission visited India in 1965-66 for evaluation of Family Planning Programme. A panel of consultants under the aegis of Programme Evaluation Organisation of the Planning Commission also evaluated the performance of family planning programme. A summary of the findings and recommendations in respect of the United Nations Advisory Mission is laid on the Table of the Sabha. [See Appendix LXVI, Annexure No. 106.] The summary of findings and recommendations of the panel of Consultants of the Programme Evaluation Organisation is contained in Chapter X of their report, copies of which are available in the library of the Parliament.

(c) Does not arise, but the Government have proposed further evaluation of the progress of the programme and have requested the Unit3d Nations to send a Mission for the purpose. The Programme Evaluation Organisation have also undertaken evaluation of the Family Planning Programme to assess the results of inputs made.

(a) what rate of interest is charged by the Reserve Bank of India from the Commercial Banks for funds made available to them for distribution as loan to agriculturists for the purchase of fertilizers;

(b) what is the rate of interest which the Reserve Bank charges for making

available funds to Co-operative Societies in the States for advancing loans to the agriculturists for purchase of fertilisers; and

(c) what are the reasons for the difference in the rates of the above two categories ?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI K. C. PANT) : (a) and (b) The Reserve Bank charges an interest of 2% below Bank rate (at present 5 per cent) in respect of the loans and advances sanctioned by it to the State Cooperative banks for financing seasonal agricultural operations, which would include the cost of purchase of fertilisers by farmers. No specific facilities are available to the commercial banks from the Reserve Bank in respect of their lending to the farmers, if any, for the purchase of fertilisers. Such financing will have to come out of their own resources or out of their usual borrowings from the Reserve Bank, on which the interest charged will not be less than the Bank rate.

(c) The concession in the matter of rate of interest is allowed to the State cooperative banks in view of the fact that the funds are routed through three levels in the cooperative credit system.
