THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SURENDRA PAL SINGH): (a) to (c) The procedure for the allotment of seats for Haj is that after retaining some seats for ad hoc allotment by Government, information about the remaining seats is communicated to the Managing Director, Moghul Lines Ltd., who are the shipping agents, and the Chairman, Haj Committee, Bombay. They consult each other and distribute the seats among various States on the basis of their respective Muslim population. There is thus no committee, as such, for the purpose.

The overall quota, which is fixed by Government, was 15000 last year. The same number has been fixed for Haj 1969. The number of seats distributed Statewise for the years 1968 and 1969 is indicated in the statement placed on the Table of the House.

VISIT OF THE DIRECTOR OF HIMALAYAN RESEARCH PROJECT TO SIKKIM

\*748. SHRI Z. A. AHMAD: Will the PRIME MINISTER be pleased to state:

- (a) whether it is a fact that Mr. Leo Rose, Director of the Himalayan Research Project-sponsored by the California University is frequently visiting Sikkim and has free access to the Palace Library there;
- (b) if so, whether Government have permitted Mr. Leo Rose and his team to work in Sikkim and other Himalayan border regions;
- (c) if the reply to part (b) above be in the affirmative, the places where they have been permitted to work;
- (d) whether Government have made any investigation into the activities of the Himalayan Research Project in India; and
- (e) if so, what are the findings thereof?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI B. R. BHAGAT): (a) to (c) Dr. Leo Rose, who is a leading member of the Institute of International Relations of the University of California, visited Sikkim on four occasions, each time for a few days. These visits took place in 1961, 1965, 1966 and 1968. Access to the Palace Library is a matter for authorisation by the Palace Authorities.

Dr. Rose was also allowed to visit Ladakh and NEFA in 1963. After the visit, he co-authored with Dr. Margaret Fisher and Dr. Huttenbach, a book entitled "Himalayan Battleground". The book supports India's standpoint.

Dr. Rose also paid a brief visit to NEFA in 1966.

To the best of Government's know-ledge, the other members of the Project confined their activities to regions which are open to foreign visitors.

(d) and (e) Following the revelation made in the U. S. Senate Foreign Relations Committee that the Project received part of its finances from the Defence Department of the U. S. Government, the Government of India have decided that the Project should be wound up.
