- 1. All India Institute of Local Self-Government, Bombay.
- 2. Indian Institute of Social Welfare and Business Management, Calcutta.
- 3. University of Lucknow (Department of Public Administration), Luck-now.

The centre at Bombay has conducted the six months 'L.G.S.' course (Post-graduate course of Higher Training for Supervisory posts in Local Bodies) which was started in January, 1968. Forty-two candidates were admitted to this course. The centre in Calcutta has started a 2i months' course for 29 nominees of local bodies in July, 1968. The Lucknow centre is starting a six weeks' course from 19th August, 1968.
