DESPATCH OF ADDITIONAL FOODGRAINS TO KERALA

THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT AND COOPERATION (SHRI ANNASAHEB SHINDE): (a) 1,000 tonnes of gift wheat has been allotted to Kerala Government for free distribution among the flood victims.

(b) No specific request for food grains to meet the situation created by floods in the State has been made by the Kerala Government.
