been referred to West Bengal Government. That Government has promised to send a reply shortly. As the stocks are in godowns the question of damage by rains does not arise.

THE MINISTER OF STATE IN THE MINISTRY OF FOOD, CULTURE, COMMUNITY DEVE-LOPMENT AND COOPERATION (SHRI ANNASAHEB SHINDE): (a) and (b) No allegation of fraud or embezzlement about Government in the Project has been received. There are some complaints against F.A.O.'s employees working under F.A.O.'s administrative and financial control. It is understood that F.A.O. is enquiring into these complaints.

- (c) No, Sir. But an allegation to this effect is being enquired into by appropriate authorities.
- (d) Government share has already been paid on due dates in accordance with the Plan of Operation signed with U.N.D.P. The question about taking action against the experts does not arise at this stage.
