(a) the details of reports received by Government regarding the happenings in the Anand Marg Ashram located in Purulia District in the Adivasi Area on the border of Bihar on the basis of which Government ordered a thorough enquiry into the affairs of the said Ashram; and

(b) whether it is a fact that the Ashram is getting assistance from the C.I.A. and other foreign agencies ?

(a) whether any complaint has been received by the Delhi Administration about the death of a young girl who was hurriedly removed to the mortuary by the police who without any investigation established it as a case of suicide;

(b) if so, whether the Delhi Administration have decided to institute an enquiry against the police officials and the police surgeon connected with this incident; and

(c) if the reply to part (b) above be in the affirmative, whether investigations have been conducted and details of the findings of the enquiry ?
