THE MINISTER OF TOURISM AND CIVIL AVIATION (DR. KARAN SINGH): (a) During negotiations between a Delegation of the Government of the Federal Republic of Germany and the Government of India Delegation held in Bonn in September, 1967 and renewed at Delhi in May, 1968, the German Delegation did propose that Lufthansa should be allowed traffic rights at Bombay in addition to the traffic rights which they enjoy at Delhi.

(b) and (c) The Government of India Delegation was unable to agree to this proposal, but was prepared to offer to Lufthansa the choice between Delhi and Bombay. At the suggestion of the German Delegation, it was decided that the negotiations should be resumed some time in October, 1968.
