- (b) The new arrangement has the dual objective of combining the specialised experience of the Tourist Department regarding tourist spots and facilities in India, with Air-Tndia's wider net work of offices and the outstanding quality of the publicity and promotion undertaken by Air-India's specialists. To ensure the closest working relationship, a Regional Director of Tourism will be located at Geneva, to Work directly with Air-India's Regional Manager-Continental Europe. All tourist promotional activities will be guided by him, and he will be in the closest touch with the Air-India's Executives at every level. The two Organisations will each maintain their spearate identities, bat this interlinking of experience and promotional activities is expected to contribute towards an increased flow of tourists from Europe.
- (c) Th-; arrangement has only just begun and full details of promotional activities for the coming season have not yet been finalised.
