The pattern of Central financial assist-e for the West Coast Road, which passes through the States of Maharashtra and Karnataka and Union Territory of Goa also, was grant-in-aid upto 50% of the cost of construction of the road from 1-4-1951 to 31-3-1955, 100% grant-in-aid from 1-4-1955 to 31-3-1969 and thereafter 100% loan assistance. The West Coast Road was included in the National Highway System on 7-3-1972 and since then the entire cost of development, improvement and maintenance of the road is being met by the Central Govt.

The proposal of the State Govt, is that not only the excess expenditure on the idual works (which is not admissible according to the terms and conditions for the grant of financial assistance for the West Coast Road) should be borne by the Central Govt, but also that the entire expenditure should be treated as grant-in-aid as against 100% loan assistance granted with effect from 1-4-1969. The matter is under consideration.
