- (vii) Ancillary units are on the verge of closure;
- (viii) Some of the units of the company might close down;
- (ix) There is apprehension of the company going into liquidation.
- (e) As on 29-3-1976, the stock of sale-* able steel at the works was 59,014 tonnes.
- (c) to (g) The company had reported earlier that the services of some temporary workers employed on specific jobs had been terminated but further information on this and other points has been called for. The Government will look into these on receipt of the information.

Deterioration in Bus Service in the Capital

*553. SHRI SASANKASEKHAR SANYAL: Will the Minister of SHIPPING AND TRANSPORT be pleased to state:

- (a) whether Government are aware that bus service in Delhi from Tilak Nagar, Rajouri Garden and Raja Garden to the Central Secretariat has deteriorated during the last six months;
- (b) whether Government have received complaints in this regard from employees working near the Central Secretariat; and
- (c) if so, that action Government have taken on these complaints.

THE MINISTER OF SHIPPING AND TRANSPORT (DR. G. S. DHILLON): (a) and (b) Tilak Nagar is connected to Central Secretariat by the services on route No. 810, and Rajouri Garden and Raja Garden are linked with Central Secretariat by the services on routes No. 810 and 820. The present services on route No. 820 are considered to be satisfactory by the Delhi Transport Corporation.

Some representations have been received from these working in the Central Secretariat complex for augmentation of services on route No. 810.

(c) It is proposed to increase the frequency of services on route No. 810 when additional buses are acquired by the Corporation.

State Level Apex Bodies

RAGHUNATHA REDDY): The States and Union Territories which have .yet to set .up State Apex Bodies are Gujarat, Jammu & Kashmir, Madhya Pradesh, Nagaland, ' Orissa, Manipur, Meghalaya, Sikkim, Delhi, Chandigarh, Goa, Daman & Diu, Arunachal Pradash, Dadra & Nagar Havel i, Lakshdweep, and Mizoram. The matter is 'being pursued with them.
