- (1) Taxation Laws (Amendment) Act, 1975.
- (2) The Conservation of Foreign Exchange and Prevention of Smuggling Activities (Amendment) Acts, 1975 and 1976.
- (3) Smugglers and Foreign Exchange Manipulators (Forfeiture of Property) Act, 1976.
- (4) The Imports and Exports Control (Amendment) Act, 1976.

Further the question of creation of Special Courts for the trial of economic offences is under active consideration.
