Submission of test results by hospitals in the National Capital

- 78. SHRI SANJAY RAUT: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:
- (a) whether it is a fact that Government hospitals in the National Capital do not submit test results of ordinary citizens within a day;
- (b) whether it is also a fact that Government hospitals in the Capital have been asked to submit annual medical tests done in a day and reports made available the next day for submission; and
 - (c) if so, the reason for this discriminatory practice?

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI GHULAM NABI AZAD): (a) to (c) Health being a State subject such information is not maintained centrally. In so far as three Central Government Hospitals in Delhi, namely, Dr. R.M.L. Hospital, Safdarjung Hospital and Lady Hardinge Medical College and its associated hospitals are concerned, the time taken for conducting different types of tests varies from test to test. The Laboratories/Departments send all the reports to the requisitioning department after result are otained, in a time bound manner irrespective of the type of patients. However, sometimes all the prescribed tests cannot be done on the same day due to technical and procedural requirement.

Introudction of new MBBS course

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI GHULAM NABI AZAD): (a) to (c) In an overall effort to imporve medical education and make it more socially oriented and suitable from the public health perspective, discussions were held with the Medical Council of India (MCI) on 4th February, 2012 regarding exposing MBBS students to rural health care settings to enable them to acquaint themselves with broad community healthcare needs.
