#### Free Pacemaker Implants for the Needy Patients

(a) whether Government proposes to provide free pacemaker implants for the poor heart patients in all the district hospitals of the country and allocate adequate funds for this purpose;

(b) if so, the details thereof; and

(c) if not, the reasons therefor ?

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI GHULAM NABI AZAD) : (a) to (c) There is no proposal to provide free pacemaker implants for the poor heart patients in all the district hospitals of the country. However, poor patients can avail of the facilities provided by Rashtriya Swasthya Bima Yojana (RSBY) and Rashtriya Arogya Nidhi (RAN) for provision of free pacemaker.
