Since, establishment of Medical College is subject to fulfillment of regulatory requirements of physical infrastructure, equipments, placement of faculty and issue of Letter of Permission by Medical Council of India, no time-frame as to when these Medical Colleges start functioning can be given.

Opening of computer education centres at tehsil level

THE MINISTER OF LABOUR AND EMPLOYMENT (SHRI MALLIKARJUN KHARGE): (a) to (c) There is no proposal under consideration of the Government for opening Computer education centres at tehsil level for providing free computer education to youth. However, Ministry of Labour and Employment has formulated a new scheme titled 'Kaushal Vikas Yojana' to set up 1500 new Industrial Training Institutes (ITIs) and 5000 Skill Development Centres (SDCs) in un-served blocks of the country including Uttarakhand under Public Private Partnership (PPP). Approval process of the scheme is on. These ITIs and SDCs are proposed to conduct demand driven courses including Computer education.
