## **Mandatory Hallmarking**

A bill to amend BIS Act so as to incorporate an enabling clause for considering mandatory hallmarking for gold jewellery has been introduced in Lok Sabha on 03-05-2012. The Hon'ble Speaker has referred the said Bill to the Standing Committee for Food, Consumer Affairs and Public Distribution on 25th May, 2012. The matter is under consideration of the Standing Committee.

(d) As on 30 June 2012, 1337 lakh gold articles & 1.69 lakh silver articles have been hallmarked. The name of jewellers or specific jewelleries can be known only after the act is amended and mandatory hallmarking comes into force.
