## Appointment of Director of Nava Nalanda Mahavihar

VEN'BLE DHAMMAVIRIYO (Bihar): Madam, the Ministry of Culture has recently appointed a Director in the Nava Nalanda Mahavihar, an internationally reputed institute, grossly violating the minimum dignity and convention of the universities, particularly a university of the stature of the Nalanda University. The appointed person is a simple M.A. Ph.D. and is working as a proof reader in the Vipasana Vidyapeeth, Nasik, Maharashtra. The appointment will destroy the institution since he is only 42 years old and is supposed to continue as Director for minimum 20 years. This is an affront to the glorious heritage, fame and tradition that the institute is enjoying since ancient times. Moreover, the appointment is not acceptable to the academic community, particularly the Buddhist world. The renowned personalities like Dr. Prof. Jagdish Kashyap, Prof. Satkari Mukherjee, Prof. Rath, Dr. Dipak Barua, Prof. Chandrika Prasad, worked as Directors in this institution, and produced more than two hundred Buddhist scholars. Some of them who are working as professors, Vice-Chancellors and diplomats are shocked to see the appointment. It is also surprising that the recommendations of the experts of the Selection Committee were ignored. In view of the above reasons, we request the Ministry of Culture to cancel the appointment of Director, Nava Nalanda Mahavihar. Thank you.

## Need to take over Regional Institute of Medical Sciences, Imphal, by the Government of India

SHRI W. ANGOU SINGH (Manipur): Madam, I thank you for giving me time to raise one of the important issues concerning the North-Eastern region. It is regarding the take-over of the Regional Institute of Medical Sciences, Imphal, by the Government of India.

Madam, the Regional Institute of Medical Sciences, Imphal, was established on 14<sup>th</sup> September, 1972 in the name of "Regional Medical College". It celebrated its silver jubliee on 14<sup>th</sup> September, 1997. This Institute covers six North-Eastern States--Manipur, Tripura, Meghalaya, Mizoram, Nagaland and Arunachal Pradesh. In August, 1976, the management of the Institute was taken over by a registered society, namely, "The North-Eastern Regional Medical College Society", and in June,
