Computerisation of Wakf Boards

1029. SHRI NARESH AGRAWAL: Will the Minister of MINORITY AFFAIRS be pleased to state:

- (a) whether Government has taken any steps to computerize the records of Wakf Boards;
 - (b) if so, the details thereof;
 - (c) how much fund has been released to various Wakf Boards; and
 - (d) the present status of the project?

THE MINISTER OF STATE IN THE MINISTRY OF MINORITY AFFAIRS (SHRI NINONG ERING): (a) and (b) The Joint Parliamentary Committee (JPC) on Wakf, in its 9th Report submitted to Parliament on 23.10.2008, recommended computerization of the records of State Wakf Boards (SWBs) with Central finance assistance. The proposal was approved by the Government and the scheme was launched in December, 2009. Under the scheme, grant-in-aid is released to a State/UT Wakf Board for setting up of a Centralized Computing Facility (CCF). The main objective of the scheme is to streamline record keeping, registration of wakf records, digitization for preservation of wakf records, tracking of legal cases and computerization of the various functions/processes of the SWB.

- (c) An amount of Rs. 1300.88 lakhs has been released to National Informatics Centre (NIC), Central Wakf Council and 27 SWBs as on 3.12.2012. The details of funds released are given in Statement (*See* below).
- (d) As on 3/12/2012, the CCF has been set up in 25 State/UT Wakf Boards and a database of 1,69,506 wakf properties has been entered in the Registration Module of the software developed by the NIC. Pre-digitization work of 70957 wakf properties has also been completed.
