Upliftment of minorities

1030. SHRI MOHAMMED ADEEB: Will the Minister of MINORITY AFFAIRS be pleased to state:

- the details of programmes for the welfare of minorities;
- how much development and upliftment of minorities has been done during the last three years and the current year; and
- what are the plans for future and the near future?

THE MINISTER OF STATE IN THE MINISTRY OF MINORITY AFFAIRS

(SHRI NINONG ERING): (a) The details of the programmes implemented by the Ministry for the welfare and upliftment of minorities are given as below:—

- (i) Multi-sectoral Development Programme (MsDP).
- (ii) Pre-matric Scholarship Scheme.
- (iii) Post-matric Scholarship Scheme.
- (iv) Merit-cum-means based Scholarship Scheme.
- (v) Free Coaching and Allied Scheme.
- (vi) Equity contribution to National Minorities Development and Finance Corporation for enhancing credit to the minorities.
- (vii) Grant in aid to Maulana Azad Education Foundation for minority welfare activities.
- (viii) Computerization of records of State Wakf Boards.
- (ix) Leadership Development of Minority Women. (Being implemented from 2012-13)

(b) The funds allocated, released, utilized, targets and achievements for the above Schemes during the last three years and the current year are given in Statement-I and II (*See below*).

(c) In the Twelfth Five Year Plan under MsDP the focus will be on blocks rather than districts and expansion of the programme to cover minority concentration towns/cities and cluster of minority concentration villages. A proposal has also been moved for greater transparency and ease in application in the Scholarship Schemes. To help evaluation of flow of benefits, disaggregated data for the different minority communities has now been sought from all Ministries under the Prime Minister's new 15 Point Programme and the States/UTs have also been requested to provide better and timely feedback. Social Audit and the appointment of an independent agency for concurrent monitoring and evaluation of various schemes included in PM's new 15 PP are being formulated for implementation during the Twelfth Five Year Plan period. The Ministry further proposes to implement five new Schemes during the Twelfth Five Year Plan period for which 'in-principle' approval has been accorded by the Planning Commission.
