## Re. Demand for the information about Governments reaction to the matter deputing an investigation team by US Consul Generals office in Calcutta to investigate into a land-related violence

SHRI NILOTPAL BASU (West Bengal): Sir, I had mentioned in the House that there was a very disturbing development regarding an investigation team deputed by the U.S. Consul General's Office in Calcutta to a place where there was some unfortunate land-related violence. The Chair had pointed out to the Government that they should go into the Geneva Convention and find out whether an investigation can be done by the staff of the Consulate Office. Can they do it?

Does it not infringe upon the question of diplomatic propriety? We are also given to understand that the Chief Minister of the State has also written to the hon. Prime Minister and the External Affairs Minister. We have also seen newspaper reports that the Minister of State has given a blanket certificate to the Consul General's Office. It is a very serious issue which concerns the sovereignty of this nation. Therefore, I would like to know whether the Government has reacted to the specific direction given by the Chair yesterday, and we would like to be informed of the position.
