Cancellation of tender for purchase of 180 Howitzer Guns

†*266. SHRI RASHEED MASOOD: Will the Minister of DEFENCE be pleased to state:

(a) whether it is a fact that the tender for purchase of 180 Howitzer Guns has been cancelled for the fourth time;

THE MINISTER OF DEFENCE (SHRI A.K. ANTONY): (a) and (b) The Request for Proposal (RFP) for procurement of 180 Howitzer Guns has been cancelled in 2012, for the third time in past ten years.

RFP for procurement of 180 Self-Propelled (Wheeled) 155mm/52 calibre guns for Army was first issued in February, 2002 to 11 firms of which only 5 firms had responded and only one qualified at technical evaluation stage. The RFP was retracted, however, due to procedural infirmities.

RFP was issued for the second-time in February 2007 to 29 firms of which only two firms responded, but one offer was rejected because of procedural deficiency, resulting in a single vendor situation.

RFP was issued for the third-time in February, 2008 to five firms of which only two responded, but neither of the two was able to meet the RFP parameters resulting in retraction of the RFP.

(c) and (b) Further, it is stated that an RFP for 100 quantity of 155mm/52 calibre Tracked Gun (Self-Propelled) was issued in January, 2011. However, RFPs for Self-Propelled Guns (Tracked) were issued earlier in August, 2008 and May, 2007 also.
