Protection of historical Chaurasi Khambe ki Chhatri

†2055. SHRI MOTILAL VORA: Will the Minister of CULTURE be pleased to state:

(a) whether Government is aware of the fact that 327 years old paintings inscribed on historical 'Chaurasi Khambhe ki Chhatri' of Bundi, Rajasthan has been

destroyed by Rajasthan Urban Infrastructure Development Programme (RUIDP) by applying plaster on it in the name of renovation;

(b) if so, the steps being taken by Government to protect historical Chaurasi Khambe ki Chhatri; and

(c) the action being taken against guilty company RUIDP?

THE MINISTER OF CULTURE (SHRIMATI CHANDRESH KUMARI KATOCH): (a) and (b) The 'Chaurasi Khambe ki Chhatri' of Bundi, Rajasthan is not a protected monument of Archaeological Survey of India (ASI). According to information received from the Government of Rajasthan, the restoration work of these paintings was executed through Rajasthan Urban Infrastructure Development Programme (RUIDP). Archaeology and Museums Department, Government of Rajasthan has stated that these paintings were originally in a very bad condition. The RUIDP has restored these paintings under the professional guidance of an expert empanelled by the State Government of Rajasthan under supervision of all stakeholders and District Collector, Bundi.

Job scam in NDA

Officers suspected to be involved have been placed under suspension and CBI is investigating the matter. Pending CBI investigation, Commandant NDA has been transferred.
