- (i) Improvement of Science Education in Schools;
- (ii) Environmental Orientation to School Education;
- (iii) National Population Education Project;
- (iv) Introduction of Yoga in schools; and
- (v) International Science Olympiad in Mathematics, Physics, Chemistry, Biology and Informatics.

The total Tenth Plan Outlay for the scheme of Quality Improvement in Schools is Rs. 115.00 crore. It has been decided, among other things, to transfer the component "Improvement of Science Education in Schools" to the State Governments/Union Territory Administrations as State Sector Scheme. The State Government of Uttar Pradesh, along with other States, would be benefited under the scheme. It has also been decided that the administration of the other four components, which normally cater to the Non Governmental Organizations, would be done by the National Council of Educational Research and Training (NCERT), an autonomous body under the Department of Secondary and Higher Education.
