ALI ASHRAF FATMI) (a) to (e) A Statement showing amounts available for SSA with the States and UTs and expenditure incurred by each State and UT during the years 2003-04 and 2004-05 is enclosed See below. The utilisation of funds available under SSA and the progress against physical targets in the past two years has been satisfactory. During 2004-05, the States/ UTs utilised 85.34% of funds available to them.

The States of Bihar, West Bengal, Arunachal Pradesh, Meghalaya, Sikkim and Delhi had a comparatively low rate of overall expenditure during 2004-05

The Central Government has taken up rigorous monitoring and review of implementation of SSA in all the States & UTs.
