Grants, Mahatama Gandhi National Rural Employment Guarantee Scheme (MGNREGS), Backward Region Grant Fund (BRGF), Rashtriya Gram Swaraj Yojana (RGSY), etc.

Officers joining commercial entities

- 91. SHRI PRAKASH JAVADEKAR: Will the PRIME MINISTER be pleased to state:
- whether the Ministry is aware that several officials of Government have been found joining commercial entities after retirement in violations of All India Services (Death-cum-Retirement) rules;
 - if so, the details thereof; and
 - the action Government has taken till date in this regard?

THE MINISTER OF STATE IN THE MINISTER OF PERSONNEL, PUBLIC GRIEVANCES AND PENSIONS (SHRI V. NARAYANASAMY): (a) Rule 26 of the All India Service (Death-cum-Retirement Benefit) Rules, 1958 provides that a pensioner shall not accept any commercial employment before the expiry of one year from the date of his retirement, except with the previous sanction of the Central Government. If a pensioner accepts a commercial employment without such sanction, it shall be competent for the Central Government to declare by an order in writing that he shall not be entitled to the whole or such part of the pension and for such period as may be specified in the order.

No such cases of All India Service pensioners who have violated the above provisions of the Rules have come to the notice of the Central Government.

(b) and (c) Do not arise.

Eleventh Lokayukta Conference

THE MINISTER OF STATE IN THE MINISTER OF PERSONNEL, PUBLIC GRIEVANCES AND PENSIONS (SHRI V. NARAYANASAMY): (a) Yes, Sir. The Lokayukta Delhi organised the Eleventh All India Lokayuktas Conference, 2012 from 2nd November, 2012 to 4th November, 2012 at Delhi.

- (b) As per the information available in this Department, the points for discussion at the above conference were, *inter-alia*, as under:—
 - (i) Strengthening of Institutions for eradication of corruption, bringing probity, transparency in governance and role of various Stake holders.
 - (ii) Role of Lokayukta.
