

Progress of airport line of Delhi Metro

†144. SHRIMATI MAYA SINGH: Will the Minister of URBAN DEVELOPMENT be pleased to state:

- (a) since when the repair work is being done on non-operational Delhi Metro due to technical faults and the current status thereof;
- (b) the faults found in this line and whether these faults have been fixed;
- (c) whether the views of the operating company of Airport Express Line and DMRC regarding the technical faults are different;
- (d) the report of the safety Vigilance Commissioner in this regard; and
- (e) the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT (SHRIMATI DEEPA DASMUNSI): (a) and (b) The repair work for the Delhi Airport Metro Express line was started in August, 2012 after approval of repair methodology. There were defects in civil works such as crushing of grout material in bearing area, shifting of bearings, etc. The repairs work has now been completed.

(c) No, Sir. There is no difference of opinion on the nature of defects.

(d) and (e) There is no Safety Vigilance Commissioner. However, there is Commissioner of Metro Railway Safety (CMRS) after whose inspection and certificate, the line is opened for commercial operations. The CMRS has not inspected the line, after repairs, so far.
