Funds for beautification of Uttarakhand

- (a) whether the Ministry has provided funds for beautification of the cities of State of Uttarakhand;
- (b) if so, quantum of funds provided during the last ten years for beautification of cities, city-wise;
- (c) if not, whether the Ministry will consider the proposals sent by the State; and
- (d) if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT (SHRIMATI DEEPA DASMUNSI): (a) to (d) Jawaharlal Nehru National Urban Renewal Mission (JnNURM) seeks to ensure sustainable development of cities by focusing on efficiency in urban infrastructure, service delivery mechanisms, community participation and accountability of Urban Local Bodies and Parastatal agencies towards citizens.

Under Urban Infrastructure and Governance (UIG) Sub-Mission of JnNURM, 14 projects on various admissible components have been approved for Rs. 40256.22 lakh for the mission cities of Uttarakhand with Additional Central Assistance (ACA) commitment of Rs. 31806.60 lakh, out of which Rs. 20225.85 lakh has been released so far for utilization. Details are given in the Statement (*See below*).

Under Urban Infrastructure Development Scheme for Small and Medium Towns (UIDSSMT) of JnNURM, 1 project for Mussoorie on sewerage component with approved cost of Rs. 6173.25 lakh and ACA commitment of Rs. 4938.60 lakh has been approved. So far, Rs. 2469.30 lakh has been released for utilization for the project.

The mission has completed its normal tenure of 7 years on 31.03.2012 and the Government has extended the period for 2 years *i.e.* upto 31.03.2014 for completion of on going projects and reforms only. It has no mandate to sanction fresh projects during the extended period.

**Proposal for supplying drinking water in
Uttarakhand under UIDSSMT**

148. SHRI MAHENDRA SINGH MAHRA: Will the Minister of URBAN DEVELOPMENT be pleased to state:

(a) whether the Ministry has received the proposal for supplying drinking water in hilly districts of Uttarakhand under Urban Infrastructure Development Scheme for Small and Medium Towns (UIDSSMT);

(b) whether any proposal has been approved; and

(c) the details of the amount spent on various schemes in Uttarakhand sanctioned under Jawaharlal Nehru National Urban Renewal Mission and UIDSSMT separately from 2009 to 2012?

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT (SHRIMATI DEEPA DASMUNSI): (a) and (b) Under Urban Infrastructure Development Scheme for Small and Medium Towns (UIDSSMT), one request for Additional Central Assistance for Water Supply Project at Mussoorie at an approved cost of Rs. 2249.00 lakhs was received from Uttarakhand Government, but due to non-availability of allocated funds the request could not be considered.

(c) Mussoorie Sewerage Project at an approved cost of Rs. 6173.25 lakhs involving Central share of Rs. 4938.60 lakhs has been sanctioned under UIDSSMT, out of which Rs. 2469.30 lakhs has already been released during 2008-09.

Under Urban Infrastructure Governance (UIG), Sub-Mission of JnNURM, during 2009-2012, 5 projects for Mission cities of Uttarakhand have been approved for various admissible components with approved cost of Rs. 11842.60 lakh. On this and other projects, ACA released from 2009 to 2012 is Rs. 15269.30 lakh. The detail of projects sanctioned under UIG is given in the Statement.
