Government has announced that it will be its endeavor to ensure that all households benefit from bank accounts in the next two years.

MoU between SBI and JBIC

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI NAMO NARAIN MEENA): (a) to (d) on 31st August, 2012, the State Bank of India (SBI) has signed a Memorandum of Understanding (MoU) with Japan Bank for International Co-operation (JBIC), which envisages to assist Japanese Small and Medium Enterprises (SMEs) customers of Japanese Regional Banks (JRBs). However, SBI assistance is envisaged in making direct investments and establishing business in India to the customers of those JRBs, which are participating with JBIC, by providing financial and non-financial services, besides providing them with funded and advisory services. The MoU is of non-binding and non-exclusive nature, and can be terminated by either party after giving a prior notice of 30 days.
