Construction of National Highways with funding by State Governments

- 611. SHRI SHANTARAM NAIK: Will the Minister of ROAD TRANSPORT AND HIGHWAYS be pleased to state:
- (a) what are the present schemes in force under which National Highways are constructed;
 - (b) the essential features of each scheme;
- (c) whether there is any scheme for construction of National Highways with funding by State Governments; and
- (d) if so, the name of the scheme, which is being implemented and what are the essential features of the scheme?

THE MINISTER OF STATE IN THE MINISTRY OF ROAD TRANSPORT AND HIGHWAYS (SHRI SARVEY SATHYANARAYANA): (a) and (b) The development of National Highways (NHs) is taken up mainly under National Highways Development Project (NHDP) & Non-NHDP. There are seven phases of NHDP covering about 47,000 km length. Under Non-NHDP, major programmes include improvement of riding quality, widening/strengthening of existing pavement, construction of bridges/ culverts etc. Besides, for development of road network in North Eastern part of the country, a Special Accelerated Road Development Programme including Arunachal Pradesh package covering about 6,418 km length of roads including State roads have been taken up. Similarly, for development of roads in Left Wing Extremism (LWE) affected areas, about 5,477 km length of roads including State roads have also been taken up.

- There is no scheme for development of NHs with funding assistance from the State Governments.
