Assistance for Institute of Mental Health, Hyderabad

526. SHRI NANDI YELLAIAH: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) whether the Ministry has received any proposal from the State Government of Andhra Pradesh for establishment of Centre of Excellence at Institute of Mental Health, Hyderabad with Central Government assistance of 30.01 crores for civil construction, provision of equipment and staff components;

THE MINISTER OF HEALTH AND FAMILY WELFARE (SHRI GHULAM NABI AZAD): (a) to (d) After consideration of the proposal received from the Government of Andhra Pradesh, the Standing Committee has recommended a Central assistance of Rs. 30.00 crore to Institute of Mental Health, Hyderabad for establishment of a Centre of Excellence in the field of mental health for meeting the cost of capital work, equipment, faculty, technical staff etc.

Out of the recommended amount, the Government has released an amount of Rs.5.28 crores in 2009-10 as first instalment to the said Institute for the above purpose, as per guidelines under the scheme.
