by applying poverty lines estimated at 2009-10 prices. The poverty estimates for 2009-10 were released in March, 2012. Whereas, on 20th September, 2011, in response to the Supreme Court's specific direction to update Tendulkar poverty line for 2004-05 to correspond to consumer prices prevailing in May, 2011 or later, the Planning Commission submitted an affidavit giving poverty lines estimated at June 2011 price level (which was the latest available price data then). The poverty lines that have emerged from the 2009-10 survey are lower because they are at 2009-10 price level, which is lower than that prevailing in June, 2011.

Special status to Odisha

715. SHRI BAISHNAB PARIDA: Will the PRIME MINISTER be pleased to state:

- (a) whether the Chief Minister of Odisha, has repeatedly made requests for grant of special status to Odisha State;
 - (b) if so, the details with status thereof;
- (c) whether the State Government of Odisha has also made a number of proposals to the Central Government for improving the lot of Kalahandi-Bolangir-Koraput (KBK) region, the most backward regions of the country, with grant of additional funds for this region and extension of the Long-Term Action Plan for fast development of this region; and
 - (d) if so, the details with status thereof?

THE MINISTER OF STATE IN THE MINISTRY OF PLANNING (SHRI RAJEEV SHUKLA): (a) and (b) Chief Minister of Odisha, in his recent letter dated 24.11.2011, has requested for Special Category Status for Odisha. He had also raised this issue on earlier occasions such as National Development Council meetings and other fora. Presently, the matter is under examination in the Planning Commission.

(c) and (d) The Special Plan for Kalahandi-Bolangir-Koraput (KBK) districts of Odisha was being funded under the Backward Regions Grant Fund during the Eleventh Five Year Plan with an annual allocation of Rs. 130 crore. The State Government has requested that the allocation for the KBK districts should be enhanced in view of gaps that are yet to be met. They submitted a draft Eight Year Perspective Plan for the KBK region for the period 2009-10 to 2016-17 with an Additional Central Assistance (ACA) component of Rs. 4550 crore. The Special Plan

for the KBK districts of Odisha has been continued in 2012-13 with enhanced allocation of Rs. 250 crore. The decision about the Special Plan in the remaining period of the Twelfth Five Year Plan will be in accordance with allocative decisions with regard to the Backward Regions Grant Fund for the Twelfth Five Year Plan.

Restructuring of CSS into ACA
