## Sick PSUs in the country

\*110. SHRI BASAWARAJ PATIL: Will the Minister of HEAVY INDUSTRIES AND PUBLIC ENTERPRISES be pleased to state:

- (a) the number of sick Public Sector Undertakings (PSUs) and their employees strength in the country as on date;
  - (b) the number of cement industries under public sector in the country; and
- (c) the details of such cement industries, both closed and operational at present?

THE MINISTER OF HEAVY INDUSTRIES AND PUBLIC ENTERPRISES (SHRI PRAFUL PATEL): (a) As per information available in the Public Enterprises Survey 2011-12 that was laid in the Parliament on 26th & 27th February, 2013 there were 64 sick CPSEs as on 31.3.2012. As per Government of India Resolution dated 6.12.2004, a Central Public Sector Enterprise (CPSE) is considered sick if it has accumulated losses in any of the financial year, equal to 50% or more of its average net worth during 4 years immediately preceding such financial year and/or a CPSE which is a sick company within the meaning of Sick Industrial Companies (Special Provisions) Act, 1985 (SICA). The list of these CPSEs alongwith the number of employees working in these CPSEs is given in the Statement (See below).

(b) and (c) As per Public Enterprises Survey, 2011-12, there is only one operating Central Public Sector Enterprise namely Cement Corporation of India Ltd. functioning under the administrative control of Department of Heavy Industries.
