(c) There is no direct link between the study and Government's price policy. Government receives and notes many such papers.

Global prices of crude oil and petroleum products play the main role in the domestic pricing of petroleum products since around 75 per cent of the country's domestic consumption demand is fulfilled through imports. The price of crude oil and petroleum products in the international oil markets has increased sharply and resulted in massive under-recoveries by oil marketing companies (OMCs). The Government recently took several steps to curtail this which included: (a) authorizing OMCs in January 2013 to increase the retail selling price of Diesel in the range of 40 paisa to 50 paisa per litre per month (excluding VAT as applicable in different State/Union Territories) until further orders; and (b) sell Diesel to all consumers taking bulk supplies directly from the installations of the OMCs at the non-subsidized market determined price effective from 18th January 2013.

However, in order to insulate the common man from the impact of rise in international oil prices and the domestic inflationary conditions, the Government continues to modulate the Retail Selling Price (RSP) of Diesel (partially) among other petroleum products. Based on the Refinery Gate Price effective 16.02.2013, the OMCs are currently incurring under-recovery of Rs.10.27 per litre on sale of Diesel. The primary objective behind the pricing reforms is the growing imperative for fiscal consolidation, the need for reducing the subsidy burden on petroleum products so as to allocate more funds to social sector schemes for the common man and for ensuring country's energy security in the long term.

Shortage of LPG supply in Andhra Pradesh

- (a) whether it is a fact that there is acute shortage of LPG supplies in the Southern States, particularly in Andhra Pradesh (AP);
- (b) if so, the details of shortage of LPG in Andhra Pradesh during the last two years, month-wise and company-wise;
 - (c) the reasons therefor;
 - (d) the manner in which the Ministry is planning to resolve the shortage;
- (e) whether it is also a fact that OMCs have made Aadhaar mandatory to book LPG cylinder; and

(f) if so, the reasons therefor?

THE MINISTER OF PETROLEUM AND NATURAL GAS GAS (SHRI M. VEERAPPA MOILY): (a) to (d) Public Sector Oil Marketing Companies, namely, Indian Oil Corporation Limited (IOC), Bharat Petroleum Corporation Limited (BPCL) and Hindustan Petroleum Corporation Limited (HPCL) have reported that there is no shortage of LPG supply in the Southern States including the State of Andhra Pradesh and they are meeting the demand of the customers registered with them. However, if backlog gets generated due to uncontrollable/ unavoidable reasons, the same is tided over by augmenting supplies to the affected markets by operating the bottling plants on Sundays/ holidays.

The company wise reasons for backlog for the last two years is given in Statement-I, II and III (See below).

(e) and (f) OMCs have reported that they have not made Aadhar mandatory to book an LPG cylinder.
